During site visit survey visual inspections were carried out and Non-destructive Test conducted on the vertical load carrying elements (Columns). The building consists of RCC structure having three wings (structures) namely Wing A (constructed in the year 2001), Wing B (constructed in the year 2006) & Wing C (constructed in the year 2014), as per the information given by the concern school authority.

It is found that the condition of the concern school building structure is safe and stable for its intended use subjected to following conditions.
